4. Other Organisations –To receive reports from outside organisations.

Item deferred due to late arrival of Cllr Hudson and PCSO Leathers - Item no.4 took place at the end of the meeting.

a. ESBC – Cllr P Hudson

Moreton Lane road safety is a breach of road traffic law and not a Highways issue – Cllr Hudson has raised this with Staffordshire Police and expects a response from Ben Adams.

Forestside – A response has now been sent from ESBC.

b. Staffordshire Police - PCSO Timothy Leathers

The Council enquired about the abandoned vehicle on Quee Lane, PCSO Timothy Leathers advised that a job had been raised and the vehicle should be removed soon.

The Council asked if monthly reports could include RTA's. It was explained that the reports are automatically generated to show only the largest percentage increase and decrease in crime. The RTAs are on a separate system and cannot be added to the monthly reports. However, reports are a continuation of how it's been done historically, if PCs would like different information, then it can be tweaked to suit. PCSO Timothy Leathers explained the current shift patterns and cover for the area, Marchington has 3 PCSO'S that cover 80 square miles, Mayfield to Barton, Abbotts Bromley to Rocester.

- 6. Council owned property updates
 - a. Play areas and outdoor park areas safety checks
 - i. Silver Lane playground monthly safety report, Cllr Nixon Report to be forwarded to the Clerk.
 - ii. Forestside playground and football pitch monthly safety report, Cllr Bicknell Painting is in progress; grass is well cut. Dizzy discs seem slippery and should be monitored.
 - b. Marchington Village Hall, Cllr Mann The hall is busy with various bookings. The boundary wall is due to be fixed in the next few months.
- 7. Cricket Club drainage issues, Cllr Hayes A drainage issue was reported by the Cricket Club. Seven Trent investigated and confirmed that a sewage pipe has burst and that it is on the Cricket Club ground. Four contractors have been contacted but it has been difficult to get them to come out and quote the job. One contractor has visited so far but not yet submitted the quotation and another contractor is due in the next week. Clerk to ask SPCA what happens if we can't get a third quotation Action Clerk

When work is complete, a record of sewerage pipe locations should be kept for future reference.

8. Marchington Woodlands Village Hall, Cllr Hayes

Cllr Hayes and Cllr Nixon attended the monthly meeting, nothing to report.

9. Highways repairs, Green Lane – Cllr Hayhurst

Cllr Hayhurst attended a talk on rights of way, boundary disputes and highways. The talk referred to section 56 of the highways act where the Parish Council could serve legal statutory notice to Highways to repair roads if Highways are not responding to reports of issues. Green Lane is in a terrible state with an abundance of potholes, a poor road service and is dangerous in times of flooding. The Council agreed that a letter be sent to Philip Atkins as a starting point - Action Cllr Morgan and Clerk
